FOOD & FUEL NOTES

Legislative Update — There has been little movement on bridging the budget gap between the Senate and House since both chambers passed their respective budgets on April 7. As reported last week, funding for the petroleum tank cleanup program remains at \$125 million in the Senate and \$130 million in the House. The stark policy differences between the two chambers' budgets have prevented them from coming to a basic agreement on how to begin the conferencing process, which under normal circumstances would already be underway. Reforming state pensions, consolidating turnpike authorities, funding the courts and reforming Medicaid remain the major issues in play. The Senate will not be meeting this week in recognition of the Easter and Passover holidays. Conference committees will likely begin meeting when the Senate returns from its break the week of April 25th. When the conferees are named, we will request that you contact them o encourage their continued support for fully-funding the tank cleanup program. < Todd Steibly, Gray-Robinson>
